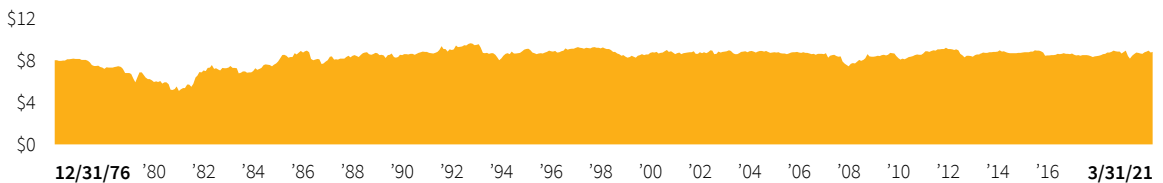
The fund invests 92.6% of its assets in investment-grade tax-exempt bonds.
