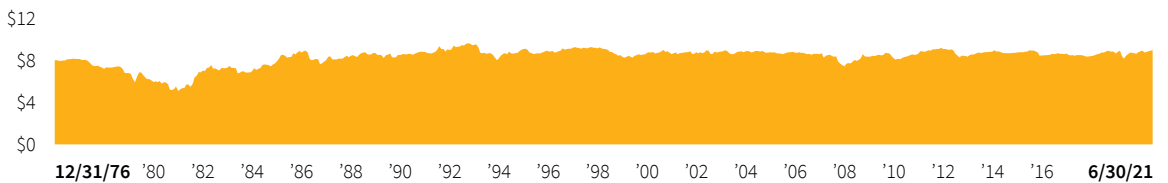
The fund invests 90.3% of its assets in investment-grade tax-exempt bonds.
