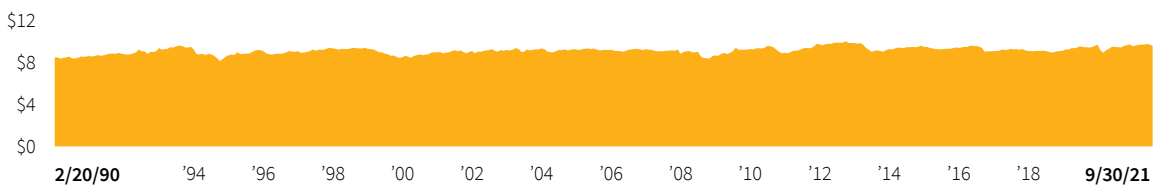
The fund invests 93.5% of its assets in investment-grade tax-exempt bonds.
